Per Stafford County Public Schools Regulation 5702-R:

1. Reduction or Waiver of Fees and Charges.

“Fees and charges will be reduced or waived for economically disadvantaged students and students whose families are undergoing economic hardship(s) and are unable to pay, which includes, but is not limited to, families receiving unemployment benefits or public assistance, such as the Temporary Assistance for Needy Families (TANF) and the Supplemental Nutrition Assistance Program (SNAP); families qualifying for the Free and Reduced Lunch Program, Supplemental Security Income (SSI), or Medicaid; foster families caring for children in foster care; or, families that are homeless under the guidelines of the McKinney-Vento Act.”

SCPS high school fees are not required prior to the start of the school year, nor during the first month of school, or all paid at the same time. We encourage you to reach out to your high school principal should other arrangements need to be made.
