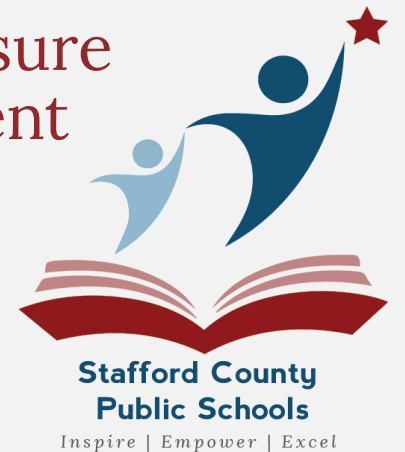

State Legislation

Senate Bill 1303

- Requires each school board to offer in-person instruction to each student enrolled in the local school division
- Requires public elementary and secondary school for at least the minimum number of required instructional hours
- Requires early childhood care and education program for the entirety of the instructional time provided pursuant to such program.
- The bill requires the Department of Education to establish benchmarks for successful virtual learning and guidelines for providing interventions to students who fail to meet such benchmarks and for transitioning such students back to in-person instruction.

Our Overarching Goal

Prioritizing In-Person Learning

Create a safe, engaging environment for students and staff, where students can actively participate in learning, build positive relationships, and demonstrate academic gains while having their physical and social-emotional needs met.



Factors Driving Recommendations

Building on Successes from the 2020-2021

Logistical & Health Considerations

- Maximizing transportation infrastructure & capacity
- Vaccine availability
- Mitigation strategies, adapting as guidelines adjust for space utilization

Student and Family Needs

- Consistent schedule for families
- Face-to-face learning is optimal for academic progress and social-emotional well-being
- Optimize student and family engagement

Staff Needs

- Provide capacity for teacher collaboration & planning time
- Ensure consistent connections with students and families
- Minimize need for concurrent instruction

Ensuring Education Access

Percent of Students Riding the Bus Pre-COVID

Elementary School	85%

In-Person Learning

Optimal Modality for Most Students

Prioritizes in-person learning as the optimal modality in alignment with state mandated instructional hours

Maximizes opportunities for student learning, acceleration, interventions and academic support and ensures social-emotional support

Enables students to experience the comprehensive school experiences including curricular, co-curricular and extra curricular opportunities.



Addressing Unfinished Learning

- Ensure transportation will be available to handle elementary schools, our largest population with the most sites:
 - Elementary focus group recommendations.
 - Youngest learners have had significant impact to learning, particularly in literacy.
 - Secondary learners have had significant impact to social-emotional.
- Ensure elementary students arrive on-time, avoiding additional instructional interruptions.
- Allow teachers unencumbered & collaborative planning time to specifically address individual student needs.

Virtual Learning

Third Party Delivery Model

Level	Virtual Offering
Early Childhood	Fully In-Person
Elementary	Available on a Case-by-Case Basis as Approved with a Term Commitment 3rd Party Delivery: K-12, Inc. for 100% Virtual
Middle School	Limited Courses Available Upon Request with a Term Commitment 3rd Party Delivery: Virtual Virginia
High School	Limited Courses Available Upon Request with a Term Commitment 3rd Party Delivery: Virtual Virginia



Virtual Learning

Elementary Virtual

- Registration required
- Provider: K-12, Inc.
- Teachers may or may not be affiliated with SCPS
- Parent commitment to serving as an instructional coach will be necessary for students to be successful
- SCPS will monitor students for academic progress for whether or not virtual learning is an appropriate fit

Secondary Virtual

- Registration required
- Provider: Virtual Virginia
- Teachers affiliated with Virtual Virginia
- Specialty, fine and performing arts, & CTE programs may not be available if a student is registered virtual
- SCPS will monitor students for academic progress for whether or not virtual learning is an appropriate fit

*Due to limited availability, SCPS reserves the right to establish eligibility criteria for and to restrict the number of students participating in the virtual program for the 2021-2022 school year. The full complement of elective courses and specialty services available to in-person students at each level (elementary, middle, high) may not be an option for those students participating in virtual instruction. For students with disabilities, the IEP process will be utilized to determine appropriate services for students learning in the virtual environment.



Timeline

- **Late May**
 - Initial orientation sessions from K-12, Inc. and Virtual Virginia for parents/students
- **June 28th**
 - Deadline to register to opt-in to transportation
- **July**
 - Bus routing
- **August 3rd**
 - Families can view bus routes
