


IB Diploma Program Admissions Policy

Open Enrollment Philosophy

The IB Diploma Program (DP) at MVHS is an open-enrollment program. Students may enroll in the full IB DP or they may take individual IB courses in areas of interest and ability. The IB DP is not a competitive placement program. There is no set limit to the number of students who may participate in IB courses or the Diploma Program. Students who attend non-IB schools in other SCPS attendance zones may request a transfer to MVHS to take part in the IB Diploma Program.



IB DP as a Program in SCPS

The IB DP is considered an "accelerated program" and therefore falls under the heading of "Gifted and Accelerated Programs" within Stafford County Public Schools. Students do *not* need to be identified as "gifted" to participate in the IB DP.

DP Admissions Process

Students who are interested in completing the full IB DP fill out and submit an "application of intent" when they register for their 9th grade classes. (Students who enroll at MVHS after the 9th grade have their applications considered on a rolling basis, as necessary.) The application is submitted to the SCPS District Facilitator via Google Forms.

Students who do not wish to complete the full IB DP do not submit an "application of intent."

DP Application of Intent

There are 4 main components of the MVHS IB "application of intent." This application is the same for both IB World Schools in SCPS – Brooke Point High School (BPHS) and MVHS.

Information Section: Students are provided with information about the program and are asked to provide their identifying information and contact information.

Enrollment Agreement: Students and parents/guardians are asked to sign an enrollment agreement.

Transfer Agreement: Students who are requesting to transfer school zones within SCPS to attend MVHS for IB are provided with information regarding the SCPS transfer policy. Since SCPS provides transportation to students who are not zoned for one of our two IB schools, placement is dependent upon a student's zoned high school (based on home address). Students zoned for NSHS and CFHS will attend MVHS. Those zoned for SSHS will attend BPHS. This is not required for students who are already zoned to attend MVHS.
