## MEMORANDUM OF UNDERSTANDING

This document serves as an agreement between all parties concerned with students enrolled in the Marine Corps Junior Reserve Officers' Training Corps (MCJROTC) program. This includes the MCJROTC staff, cadets, and their parent(s) or guardian(s). Both the signature of the prospective cadet and the signature of the prospective cadet's parent/guardian are required on this document for participation in the program. Information contained in this document is supplemental to that contained in the course Syllabus, Parent Welcome Letter, and the Cadet Handbook.

The cornerstones of MCJROTC are the character traits, leadership skills, and habits of self-discipline that are taught to each cadet. Consequently, it is imperative that each cadet is notified of, and agrees to comply with the basic standards of conduct established for the MCJROTC program. Failure to comply with these standards of conduct and the additional regulations outlined in the Cadet Handbook may result in disenrollment from the MCJROTC program.

## STANDARDS OF CONDUCT

- Display the highest degree of integrity (never lie, cheat, steal or tolerate those that do).
- Always be respectful to school faculty and staff (do not disobey, ignore, or use disrespectful language, tone of voice, or gestures).
- Do not use illegal drugs or alcohol.
- Always be respectful of others regardless of race, creed, ethnicity, religion, or country of origin.
- Adhere to all school regulations and public laws.
- Adhere to all grooming standards (to include hair regulations) outlined in the Cadet Handbook.
- Adhere to the <u>uniform wear and care regulations</u> (to include weekly uniform wear) outlined in the Cadet Handbook. Uniforms and additional USMC property will be issued to cadets during the course curriculum. Any willful act or negligence on the part of a cadet affecting USMC property shall be the responsibility of the parent/guardian to fully compensate MCJROTC for repair or replacement.

In addition to these standards, compliance with other MCJROTC directives outlined in the Cadet Handbook is expected of cadets at all times. Any undue discipline issue(s) will result in loss of rank and leadership assignments. This form, along with the course syllabus and VHSL physical, must be returned prior to the year-long class drop date or you may be dropped from this class/program.
